Leeds LMC is planning an important event for GPs and practice managers to focus on premises issues. We know that many practices are experiencing problems – perhaps struggling in outdated surgeries which are too small and not fit for purpose or trying to deal with difficult lease, rent and service charge issues.

At the same time GPs are being told of the need for new ways of working, hubs and the requirement for more care to be provided in community-based settings – all of which would necessitate significant investment in order to provide suitable premises. Many practices have applied for funding support but have so far failed to see this materialise.

For other practices, it is problems with their premises that lead them to make big decisions about the future of their whole GMS or PMS contract, or even decide to close altogether.

The LMC event to be held on **Tuesday**, **26**<sup>th</sup> **September** will bring together an experienced property lawyer, the estates advisor responsible for the recent premises audit in Leeds and a member of the Leeds CCGs Partnership. They will discuss how practices can deal with current

problems in the short term and how we can plan together to develop premises fit for our patients and our staff as well as respond to the challenges of primary care in the 21<sup>st</sup> century. There will be an opportunity for questions and we hope you and your colleagues will be able to join us for this important meeting.

#### **BALLOT OF GP PRACTICES**

We can now confirm that the Electoral Reform Services wrote out to all practices in England on the 10<sup>th</sup> July 2017 to inform them of how to take part in the BMA's ballot on whether or not practices would be willing to collectively close their lists.

Please find attached a letter and set of FAQs on the contractual and legal aspects of the BMA's ballot. GPC England needs a clear understanding of the views of all GP practices on this issue and to receive a true picture of what practices would be prepared to do. #### PCSE OUTSTANDING GP REGISTRAR PAYMENTS

We are still receiving reports of some practices with outstanding GP trainee payments despite persistent chasing by individual practices and Leeds LMC.

The LMC held a meeting with Capita on Friday 7<sup>th</sup> July 2017 where this issue was firmly raised with the Capita National Engagement Team (NET). They have proposed to work up a solution to resolve all outstanding GP registrar reimbursements prior to the August intake where possible.

In order to assist and support Capita with this task the LMC have been busily collating all outstanding payments on behalf of Leeds practices in readiness to submit to Capita as one combined list w/c 31<sup>st</sup> July 2017 for action.

We apologise to those practices who have already submitted this information and have had the agonising wait on progress. We are continuing to work closely with PCSE to ensure all cases are resolved as a matter of urgency.

The LMC will continue to keep you informed on progress regarding this matter and appreciate your patience.

# LTHT - LEEDS eREFERRAL & eTRIAGE PROJECT

Leeds Teaching Hospitals, in collaboration with Leeds CCG is undertaking a piece of work to revise and improve the way it receives referrals from General Practice. The choose and book system was launched in 2005 (relaunched in 2015 as eRS) to enable patients being referred to secondary care to have a choice of hospital, date and time of their appointment. The system also introduced a number of challenges for both primary and secondary care, namely the additional pressure on General Practice to facilitate choice for their patients whilst still ensuring patients being referred are booked into the most appropriate appointment. For LTHT the challenge has remained ensuring there is adequate capacity being made available to enable General Practice to be able to book their patients in to appropriate clinic appointments.

Over the past 12 years the number of referrals being sent through the Choose and Book/ eRS system has been stable at 50%. The remaining 50% of referrals to LTHT are received in multiple methods, with the majority being through the post. Having these multiple routes can lead to

inequitable wait times for patients, delays in processing patient's appointments and lead to poor patient experience if they do not get the right appointment first time.

In April 2016, work commenced on a new citywide project called eReferral & eTriage. The scope of the project was to ensure that all GP Outpatient referrals could be received, processed and triaged electronically by the Trust, which would result in a safer and more efficient referral pathway with the right patient, being seen in the right clinic, at the right time.

The new process introduced involves simplifying the eRS system to allow General Practice to refer to LTHT by referring electronically to a single specialty without the need to book the appointment. This referral is then promptly triaged electronically (within 2 working days) by a consultant team and then a decision is made on what the next steps of the patient's care need to be. This could be an appointment, diagnostic tests or advice back to the referring GP.

In October 2016, this was piloted in 3 specialties - Gastroenterology, Upper GI and Colorectal Surgery. The new process has seen multiple benefits including 44% of referrals having their priority changed to a more urgent appointment (with 5% being upgraded to a 2ww), more streamlined pathways as patients are receiving tests first and the number of patients waiting over 3 months for their follow up appointments significantly falling due to the outpatient capacity released, with patients who need a face to face appointment booked into the most appropriate clinic with most appropriate clinical team.

Due to the success of the pilot, we have now commenced a trust wide roll-out programme during 2017/18, with specialties to be covered agreed with CCG colleagues in response to GP feedback.


# **HEALTH EDUCATION ENGAND GP RECRUITMENT CAMPAIGN**

#### NHS HEALTHCHECKS

We have been provided with feedback about the impact of the NHS Health Check programme in Leeds and the details are below. A modified template for NHS health checks is now being installed although we are aware that there are may still be some further minor changes to this. The LMC remains concerned that the workload related to this scheme has grown, particularly with the encouragement to offer statins to patients identified as having a 10-20% risk. We continue to raise this with Public Health England.



#### RCGP SAFEGUARDING ADULTS TOOLKIT

A Safeguarding Adults at Risk of Harm Toolkit is now available on the RCGP website.

This toolkit is aimed at supporting safeguarding development in primary care, embedding safeguarding practice, ethos and culture.

Developed by the RCGP's Clinical Innovation and Research Centre (CIRC), with support from NHS England (London region), this toolkit contains resources to assist general practices to identify adults who are at risk of being, or who are being, harmed and making an effective referral should it be needed.

The toolkit provides info sheets, templates, and guides for all the primary care team. Examples of resources include top tips for deciding if you need to and how to make a safeguarding adult referral, a sample practice policy and guidance on coding and management of safeguarding information.

# Fee-paid Medical Members of the First-tier Tribunal, Social Entitlement Chamber

Number of vacancies: 176

Fee: Between £322.20 and £386.84 a day, depending on the number of sitting days

Location: England, Scotland and Wales

This is an exciting opportunity for medical professionals to use their skills and knowledge to make important decisions that will make a real difference to people's lives.

### About the role

The Social Entitlement Chamber of First-tier Tribunal hears appeals relating to a wide range of benefit decisions made by central and local government and is now seeking medical members for the first time since 2012.

As a medical member of the Tribunal, you may hear appeals relating to:

- personal independence payments
- disability living allowance
- attendance allowance
- employment and support allowance
- benefits for industrial injury or disease
- compensation recovery, including NHS recovery claims
- vaccine damage payments

You will use your professional expertise to assist the tribunal to understand the medical evidence provided.

To determine the appeal, you and your fellow tribunal members will consider evidence, find facts and apply the relevant law to reach a fair decision.

You will receive appeal papers, some of which can be substantial and complex, well before the hearing to enable you to prepare.

#### Who can apply

You must be a registered medical practitioner to be eligible to apply. 'Registered medical practitioner' means a fully registered person within the meaning of the Medical Act 1983 whether or not they hold a licence to practise under the Act.

Your registration must also be unconditional. Conditional registration is where a doctor has either been issued with a warning, been referred to a Fitness to Practice Panel or had restrictions imposed upon their registration with the General Medical Council.

The JAC encourages diversity and welcomes applications from groups currently underrepresented in the judiciary. The principles of fair and open competition will apply and recommendation for appointment will be made solely on merit.

# About the appointment

If you are successful, you will be assigned to a region and allocated to a primary hearing venue, though you may be invited to sit at other locations as well.

You will be expected to make yourself available to sit for at least 15 days a year for tribunal business. Many members currently sit at levels significantly higher than this but are free to decline to do so should other commitments make it impractical. You will also usually be required to attend up to 3 training days a year.

The daily fee varies depending on the number of days sitting. The fee is £322.20 for the first 20 sitting days in any financial year and £386.83 thereafter.

As a medical member you may hear cases that involve industrial injury or disease that require a medical examination. These are usually allocated to those possessing relevant specialist knowledge such as orthopaedic surgeons, neurologists, rheumatologists and chest physicians.

# Selection process

The selection process is managed by the Judicial Appointments Commission (JAC). You will need to complete an online application when the selection exercise launches.

The online application includes:

- your personal profile (including career history), character and diversity information
- a statement of suitability that provides evidence to demonstrate how your skills and experience make you suitable for the post

When completing your statement of suitability, you should read the <u>job description</u> and the <u>competency framework</u> which lists the ways in which a person demonstrates the required skills and abilities when working effectively in post. Your statement of suitability should not exceed 750 words.

You will also be asked to provide contact details of 2 independent assessors (referees) who can provide evidence-based examples of your performance in your profession against the competencies. Guidance is available to help you decide who to choose as your independent assessors. The JAC will only contact your independent assessors if you are shortlisted to attend a selection day.

All eligible candidates will be invited to attend a short competency based interview with situational questions. Interviews will be held regionally and are expected to run from 16 October.
