Seasonal influenza vaccination programme 2024/25

Please see below link to the national flu immunisation letter outlining the campaign for Autumn 2024/25. Practices are advised to check the reimbursable vaccines that have been confirmed, cross check this against their orders for 2024 and adjust if applicable. Practices should also note the proposed changes to the start of the campaign and review against proposed delivery dates if known.

It may be advisable for practices to review eligible cohorts particularly in the 2 & 3 year olds, 6m-18 years clinical at risk groups and also pregnant women. We know practices have had issues in previous campaigns with accurate data around pregnant patients so validation of this cohort prior to the campaign is advised.

Providers are encouraged to align delivery of the flu vaccination programme with other commissioned vaccination programmes for which the patient may be eligible (for instance shingles, pertussis, or pneumococcal vaccines) where it is clinically acceptable, operationally feasible, and where the patient is content. Where co-administration may not be feasible providers must make every effort to encourage individuals to take up the offer of every vaccine they are eligible for.

Enhancing GP record updates from pharmacies

New functionality to provide practices with structured information about pharmacy consultations for blood pressure checks, contraception and Pharmacy First (minor illness and clinical pathways) will begin a phased roll out this week. Practice staff will no longer have to manually manage this information via NHSmail; data will go straight into the workflow and can be automatically filed or viewed and filed with a single click. Practices should see a gradual increase in messages as pharmacy systems go live.

New evidence collection on eczema in children

The National Institute for Health and Care Research (NIHR) has published a new evidence collection on [Eczema in children: uncertainties addressed](#).

Several studies show that common interventions for eczema don't help. The collection brings together major NIHR research on the prevention and treatment of eczema, allowing healthcare professionals and families of children with eczema to focus on what is effective. It also explores the support children and their families need, to understand and self-manage their eczema effectively.

NHS Cervical Screening Programme support for people who find it difficult to attend cervical screening

[The updated information leaflet for people who find it difficult to attend cervical screening has now been published on GOV.UK.](#) Changes have been made to the language, tone, and format of the leaflet and all references, statistics and images have also been reviewed and updated accordingly. Additional information has also been added to the leaflet; including links to national FGM support clinics, added in response to feedback from the Domestic Abuse and Sexual Violence Programme. Providers of cervical screening sample taking services are asked to signpost participants to this resource, as individuals can use this information to help them to decide whether to attend and to prepare for their cervical screening appointment.

Medical Examiners Leeds TPP S1 Primary Care Guidance

There are limited changes for Emis practices and guidance on the process will be shared in due course.

GP Connect issue

Following recent reports that NHSE has been exploring using GP Connect as a means of centrally pulling patient data from practices, the BMA is seeking immediate clarification from relevant stakeholders. Data transferred via GP Connect is shared on the clear understanding that it is used for direct care. The deployment of the platform for any other purposes – including to circumvent GPs statutory role as data controllers, and access patient data for uses other than direct care is a clear contravention of the agreement put in place to use GP Connect.

GP Registrars survey highlights increased levels of burnout and worries about future

A [survey by the BMA's GP Registrars Committee](#) showed that GP registrars are facing increased levels of burnout and are worried about their career and health prospects early in their careers.

In addition, under 10% of those who took part in the survey said they intend to work as a full-time GP, with just less than 20% stating that they feel confident of their future as a GP working in the UK.
